## FOREWORD- HON. COMMISSIONER OF WOMEN AFFAIRS AND SOCIAL DEVELOPMENT

The development of the National Action Plan (NAP) for the implementation of the United Nations Security Council Resolution (UNSCR) 1325 has become imperative for the inclusion of Women in the process of peace building, peace keeping, conflict resolution and management in Kano State. This has become so because, Nigerian women and Kano State women in particular have paid a heavy price in the long and violent conflicts that have been ravaging the country especially in the past two decades. The women have continued to endure unprecedented levels of sexual violence and assault, along with related HIV infection, involuntary pregnancies and health complications as a result of abuses.

Often, their male family members have gone to participate in the conflicts or have been maimed or killed, leaving the women headed households to fend for themselves and their entire family. Women even at Internally Displaced Persons (IDP) camps experience increased insecurity that comes from not having their support systems available. They suffer food insecurity that comes from not having adequate means of livelihood and from culturally prescribed, and in some cases, legal prohibition on owning land. Women and girls live in fear of being kidnapped and used as war exploits, sex slaves and domestic servants. Additionally, they suffer from post-traumatic stress disorder and other psychological consequences of conflicts. The incidents of flood and farming in the country have exacerbated the situation of women exposing them to further pressure and untold hardship.

The United Nations Security Council Resolution 1325 on women, peace and security, which was adopted by the Security Council on 31<sup>st</sup> October, 2001, presents a comprehensive political framework within which women's protection and their role in peace processes can be addressed. For the first time, the Council called for comprehensive assessment of the impact of armed conflict on women and girls, the role of women in peace building and the gender dimensions of peace processes and conflict resolution.

The UNSCR 1325 is dedicated entirely to the link that exists between armed conflict, peace building and the gender dimension and builds on Convention on Elimination of all Forms of Discrimination against Women (CEDAW), the Beijing platform for Action, the Windhoek Declaration and the Namibia Plan of Action on mainstreaming, a gender perspective in Multi-dimensional Peace Support Operations adopted in Windhoek in May, 2000. The UN Resolution 1325 provided

the first international legal and political framework recognizing disproportionate impact of armed conflicts on women as well as the pivotal role of women in peace building. It acknowledges the importance of the participation of women and the inclusion of gender perspective in peace negotiations, humanitarian planning, peace-keeping operations, post-conflict peace-building and governance. It is first and foremost about peace and security but rooted on the premise that women's inclusion (their presence and participation) in the peace process, their perspectives, or their contribution to peace talks will improve the chances of attaining viable and sustainable peace in our great State, Kano.

A State Action Plan (SAP) reflects government's commitment as well as accountability in ensuring the security of women and girls during armed conflicts and enhancing their active and direct participation in conflict prevention and peace building as well as post-conflict efforts. It is also a practical and operational tool for those affected by armed conflicts - women, children and communities to be informed about the government's response to their plight including assistance programme options available to them.

For frontline enforcement agencies and other peace-keeping forces, the SAP affirms their significant role in protecting the physical safety and security of women and girls from sexual and gender - based violence and in identifying their specific needs in times of crises as SAP enjoins Security Agencies vis-a-vis women, girls and other vulnerable groups in the communities during such emergencies.

The SAP further serves as a useful road map in defining the important and distinct roles of implementers of UNSCR 1325 both at the policy and enforcement levels in Kano State. It ensures that government programmes responds to immediate and long term needs of women and children before, during and after conflict. Kano State Government, Civil Society Organisations (CSOs), Community Based Organizations (CBOs), Faith Based Organisations (FBOs), and all relevant stakeholders are engaged in peace, security, governance, elections and humanitarian efforts will find the road map useful. Development partners who seek to provide support to address gender inequality in all pillars relevant to Nigerian and Kano State situation through Prevention, Protection, Participation, Promotion, and Prosecution will provide the needed guide to be part of strengthening women, peace and security processes in the State.

I wish to express to you all that the implementation of the SAP is the key to result - oriented and success story in the Women, Peace and Security agenda in Kano State, Nigeria and Africa in general.

#### **Background of Kano State**



Kano State is located in North-Western Nigeria. Created on May 27, 1967 from part of the Northern Region. Kano state shares borders with Katsina State to the North-West, Jigawa State to the North-East, Bauchi State to the South-East and Kaduna State to the South-West. The capital of Kano State is Kano. The State has a total of 44 Local Government Areas and an estimated population of 11,058,300 and covers an area of 20,131 km<sup>2</sup>. Officially, Kano State is the most populous state in the country. The state is mostly populated by Hausa people.

Kano has seen a consistently high level of gender-based violence in the first quarter of 2015 with 20 incidents reported, compared with the 23 incidents last quarter of 2014. The exploitation of gender for the insurgency campaign waged by Boko Haram remains a significant issue in the state, along with localized sexual violence.

In December 2014 in Kano, a 13 year old girl was arrested by police carrying a suicide vest. Another two females carried out a suicide attack in a Kano textile market in the same month.

Rape of women and young girls was particularly prevalent in November, 2014 with four cases reported including a girl as young as 7 years old. In December, 2014 a 15 year old girl was abducted and sexually abused, and a woman's 10 year old son was murdered by her jilted 14 year old daughter-in-law.

Kano has an overall increase in reported incidents for this quarter with many reports, compared with the 27 reported incidents from last quarter. The higher numbers for the previous August-November 2014 period are partly due to the retrospective data provided by a partner organization, which highlighted important trends in domestic and sexual violence within Kaduna. General trends surrounding

violence perpetrated against girls and women remained prevalent in the November 2014-January 2015 period. Recently, Kano has recorded cases of raping and assassination of married women in some areas in the State especially in the metropolis.

An upsurge in targeted insurgency violence towards vulnerable groups also occurred in December in Kano, with 17 aged women and children killed in one village attack.

#### Introduction

The Women Peace and Security Network (WPS-N), Kano is a coalition of women organisations partnering to improve the course of women issues in peace building processes. The network has as its objective the advocacy for the domestication of the National Action Plan on Violence Against Women and Girls (VAWG).

Statistics and realities on ground have shown that there is daily recurrence of Violence Against Women and Girls (VAWG) which results to increase in the rate of VAWG. These VAWGs constitute issues such as rape, child labour, child trafficking, physical brutality on women and girls, unlawful divorce, etc which threaten the Peace and Security of women and young girls. In light of this, the WPS-N in Nigeria deemed it important to make a giant stride towards the domestication of the United Nations Security Council Resolution (UNSCR) 1325 i.e the resolution against VAWGs.

However, the WPS-N, Kano which is a coalition of women organisations striving towards improving the lives of women and girls especially in peace processes, deem it important to advocate for the domestication of the NAP to the State Action Plan (SAP) in Kano State based on the challenges faced by them. The SAP when domesticated will enhance the protection of women and girls in line with the culture and tradition of the people of Kano State.

The validation workshop is designed to bring together all relevant stakeholders such as Civil Society Organisations, Women Groups, Religious and Traditional leaders, members of the academia, Legal practitioners, members of Security agencies, the media, etc to review the NAP document in accordance to the culture and tradition of the people of Kano state and develop the SAP and also ensure that words are translated into actions.

#### **Objectives of the Workshop**

- 1. To create an avenue for discourse with all relevant stakeholders on issues of Peace and Security of Women and Children with reference to the National Action Plan (NAP) on Violence Against Women and Girls (VAWG).
- 2. To develop the State Action Plan (SAP) in line with the culture and tradition of the people of Kano state.

3. To develop a technical budget for the implementation of the SAP on violence Against Women and Girls in Kano State.

#### **Management Structure**

The implementation of the SAP will be championed by a Steering Committee led by the Honourable Commissioner, Ministry of Women Affairs and Social Development with support from all relevant stakeholders such as the Ministries of Education and Health, the Women Peace and Security- Network (WPS-N), Kano, Civil Society Organisations, Community Based Organisation, Faith Based Organisations, etc.

The implementation process will be funded by the Ministry of Women Affairs and Social Development through its allocation for the State Government.

In addition, Review of activities towards the implementation of the SAP will be carried out on quarterly basis to ensure efficiency and effectiveness of the programme. As such, recommendations will be made quarterly to the steering committee to enhance effectiveness.
